Guidelines

- Booth set up can begin at 12:00 p.m. and must be completed by 3:15pm.
- No vehicles may be parked adjacent to booth/on the field during the event.
- Vendor booth must be staffed for the entire five (5) hours of the event.
- No booth clean-up or equipment removal may begin prior to 8:45pm.
- Vendors may not **sell** any food or beverages.
- No alcoholic beverages may be offered during the event.
- Taste of Lancaster County will work with all vendors to ensure that promoted services are consistent with the policies and guidelines of Walnut Creek Recreational Area, and Lancaster County.
- Handouts, coupons, and/or other promotional materials are strongly encouraged as a way to promote your business, but are not required.
- You will have a staff member's direct contact information to reach at all times for any assistance throughout the event.
- You are allotted 4 event ticket wristbands. These can be used for you, and your assistance. If you do not need all 4 for business purposes, you are welcome to give them to friends or family members.

Space Requirements

- Each vendor booth is required to have an open canopy tent; one (1) table with a tablecloth; one (1) frontal business identification sign; hand sanitizer.
- Tent/table/chair set-up and removal.
- Trash removal into provided trash bags.
- Staffing for booth throughout event.
- Please let us know if you will be using a generator. Vendor is responsible for providing their own power, and reading any county requirements for generator regulations. The chamber staff will be happy to point you in the right direction if you have any power questions.
